



Why is this important?

Freedom of information is a basic right, insured by the EU Convention on Human rights, but what if journalists are wrong or have bad intentions?



When journalists release information, it is forever there. For example, once a TV story labels someone a thief, anyone who "googles" their name, sees it.





Law has to protect everyone: innocent people must be protected against lies and journalists must be protected so that they have freedom to report truth.



How does law and media connect

- In most European countries, laws protect:
- Journalists
- People, who share information with media
- The public





How does the law protect journalists? (most common aspects of EU practice) Law must insure press freedom and allow journalists to search for and publish information on any topic (censorship is outlawed).



In many countries, journalists are allowed to refuse a task if is contradicts their beliefs. For instance, this is the case in Latvia.



Journalists must have a right to express opinions and beliefs, they are allowed to analyze events, not only convey facts. This right has been established by the European court of human rights.







How does the law protect sources?




People, who bring information about wrongdoing to journalists (for instance, about corruption) are called "whistleblowers".





In several EU countries law gives journalists the right to protect the "whistle blowers" and keep their identity secret.



Even though this right is also protected on EU level, journalists still have to fight authorities to execise this right.





In some countries, courts can oblige journalist disclose sources of the information. For instance, in Lithuania.




In Latvia: investigative journalist had to go to European court of after her home was searched by police attempting to find information on a "whistleblower".



How does the law protect the public?

Journalists have an obligation to be objective and reflect all sides of a problem/story. For instance Lithuanian law says:



If journalists make a mistake, they have to retract the information.





If journalists spread false information, they can be taken to court (that is called libel and defamation).






News should be separated from opinions.



In many countries, hate speech and incitement to violence in media is illegal, it is also regulated by an EU Directive.



Journalists have to protect identity of victims of crime, and get consent of a parent when publishing information about children (under 18).







Journalists have to balance their duty to report information, important to the public with persons right to privacy.



Who regulates media and sees if journalists follow the law?

State regulatory bodies (for radio and TV), they have a right to courts, as part of the legal system.











Self-governing structures and Ombuds - internationally considered as an alternative for courts.





Sometimes law is used against journalists ... by politicians, who want to limit freedom of speech.



What if it all goes wrong?

Sometimes law is used to limit journalistic freedom. Some examples

Poland: Politicians took control over media with a new law.



North Macedonia: election commission can monitor media content.









Hungary: two media outlets forced to close following Orbán's electoral win.





Sometimes things are not black and white



Journalists have a right to express opinions and analysis, but sometimes politicians do not like this.



Freedom of information does not cover state secrets, like information about the army or secret services. But what if journalists think this is important?
